The surface to be painted must be dry, with a minimum temperature of +8 °C and relative humidity of less than 80%. Radiator heating must be switched off.

Cleaning of tools

Clean tools with water. Tikkurila Pensselipesu Tool Cleaner is recommended to remove slightly hardened paint.
